FOSTER AGREES TO IMMEDIATELY RELINQUISH A WIN FOSTER DOG UPON REQUEST OR PLACEMENT INTO A WIN APPROVED ADOPTIVE HOME. IN THE EVENT, A FOSTER FAILS TO RETURN OR RELINQUISH A DOG UPON THE REQUEST OR DEMAND OF WHEATENS IN NEED AND, LEGAL ACTION IS REQUIRED, FOSTER WILL PAY ALL TRAVEL EXPENSES, COURT COSTS, AND ATTORNEY FEES ASSOCIATED WITH SAID LEGAL ACTION. BOTH PARTIES AGREE THAT LEGAL ACTION WILL BE UNDER THE JURISDICTION OF THE COURTS IN FORT BEND COUNTY, TEXAS.
